



WAIVER AND RELEASE OF LIABILITY Kearney Area Table Tennis Club (KATTC)

THIS DOCUMENT IS IMPORTANT AND SHOULD BE READ IN ITS ENTIRETY. All participants must sign this waiver prior to participating in any Kearney Area Table Tennis Club activities.

In consideration of being allowed to participate in any way in the **Kearney Area Table Tennis Club** athletic program, and related events and activities, held at **First Baptist Church of Kearney** (and/or at other facilities or tournament locations when applicable), the undersigned agrees to the following:

1. Inspection of Facilities and Equipment. I agree that prior to participation, I will inspect the facilities and equipment to be used. If I believe anything is unsafe, I will immediately advise a KATTC board member or volunteer of such condition(s) and will refuse to participate until the issue is addressed.

2. Acknowledgment of Risk. I acknowledge and fully understand that participation in table tennis and related activities involves risk of serious injury, including permanent disability or death, and severe social and economic losses. These risks may result not only from my own actions, inactions, or negligence, but also from the actions or negligence of others, the rules of play, or the condition of the premises or equipment used. I further understand that there may be other risks not known or not reasonably foreseeable at this time.

3. Assumption of Risk and Release of Liability. I assume all of the foregoing risks and accept full personal responsibility for any damages following such injury, permanent disability, or death. I hereby release, waive, discharge, and covenant not to sue the **Kearney Area Table Tennis Club, First Baptist Church of Kearney**, their affiliated organizations, board members, administrators, volunteers, coaches, agents, sponsors, and any owners or lessors of premises used to conduct club activities (collectively referred to as the "Releasees") from any and all claims, demands, losses, or damages on account of injury, including death, or damage to property, caused or alleged to be caused in whole or in part by the negligence of the Releasees or otherwise.

4. Club Rules and Conduct. I acknowledge that I have read, understand, and agree to abide by all Kearney Area Table Tennis Club rules, policies, and codes of conduct.

ACKNOWLEDGMENT: I HAVE READ THIS WAIVER AND RELEASE OF LIABILITY, FULLY UNDERSTAND ITS TERMS, UNDERSTAND THAT I HAVE GIVEN UP SUBSTANTIAL RIGHTS BY SIGNING IT, AND SIGN IT FREELY AND VOLUNTARILY. THIS WAIVER RELEASES LIABILITY FOR NEGLIGENCE AND CANNOT BE MODIFIED ORALLY.
